## U.S., North Korea Agree to Escalate MIA Searches

KUALA LUMPUR (Reuters) - The United States and North Korea ([news](#) - [web sites](#)) have agreed to expand operations to recover the remains of American troops listed as missing from the Korean War, a U.S. official said on Saturday. The agreement was reached after four days of talks between U.S. and North Korean officials in Kuala Lumpur to set next year's schedule to search for the remains of more than 8,100 American troops still listed as missing in action from the 1950-53 war. "For next year, we agreed that we will significantly escalate the operations," Alan Liotta, the U.S. chief negotiator, told a news conference. He said under the 2001 agreement, the U.S component of the joint teams would be expanded to 28 from 20 this year and the length of each operation would be increased to 32 days from 26. It was also agreed that the areas around the Chosin Reservoir be included in the operations apart from the current areas in Unsan and Kujang counties. Liotta said 10 operations would be conducted in the three areas, where the remains of more than 950 American troops were believed to be located, between April and November. Five joint recovery operations this year have found 65 sets of suspected remains of U.S. servicemen, which have been sent to the United States for identification. Forty-two sets of remains were found between 1996 and 1999, of which five have been positively identified and a further 10 are in the final stages of verification. Liotta said that although there were some differences, the talks went smoothly. "We have to work out different approaches. But we are very pleased with the negotiations, both sides came to talk and see how we can escalate the operations," he said. The agreement also establishes a procedure for a sharing of records and data related to witness interviews, potential burial locations and other information not previously made available from the North Koreans

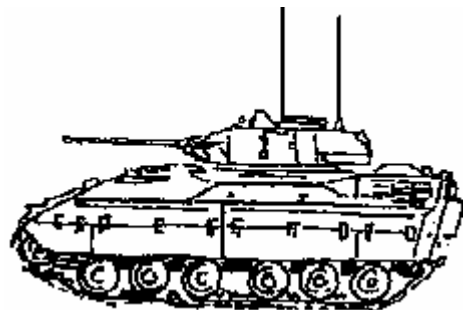

## Regimental History during the Spanish American War

In this edition of the Dragon we continue with the Regimental history, covering the Spanish-American War and the Regiment's redeployment to the United States.

In response to the declaration of war against Spain in April of that year, the Regiment, which had again been scattered throughout the West, assembled at Huntsville, Alabama by 12 October 1898. There it began a rigorous training program at Camp A.G. Force, Alabama until 15 November. By that time the Regiment had been recruited to a strength of 1348 men, with companies averaging 100 men. On 23 November, the regiment received orders to proceed to Savannah, Georgia, arriving there on the 27th. Within two hours of arrival the regiment was on board the Transport "Chester". Plagued by bad luck, the transport ran aground on a reef below the city twice before the Regiment could finally get under way.

The Regiment arrived at the harbor of Nuevitas on 4 December, with the band and A Company going ashore on the 5th to participate in the flag raising ceremony over the port. The rest of the Regiment disembarked on the 7th and went into camp outside the city. On 11 December Headquarters, C, D, G, L, and M Companies left for Puerto Principe. Companies A, B, F, H, and I left on the 12th and went into camp three miles from the city. Companies E and K went into permanent camp at Nuevitas. The camp near Puerto Principe was named Camp Allyn Capron.

On 9 February 1899, a battalion consisting of Companies B, F, I, and L marched about 110 miles to Ciego de Avila, arriving on the 16th and establishing a camp about a mile outside the town. They did so in response to growing alarm over insurgent activity in that vicinity from bands led by several former senior officers. Through clever diplomacy and hefty argument, the battalion was able to disarm and disband the insurgents. After this, the Regiment remained in the area of Puerto Principe until that winter.

The Regiment departed for the United States from Nuevitas on the Transport "Sedgwick" on 5 January and arrived in New York City on 9 January 1900. Upon arrival the Regiment was again dispersed, with the band, Headquarters, and Companies A, C, and D moving to Plattsburg Barracks, New York. Company B moved to Fort Ethan, Vermont. The 3d Battalion was stationed at Fort Columbus, New York. On 8 February Companies C, D, E, F, G, L, and M temporarily moved to Washington for duties in connection with the funeral escort of the late Major General Lawton. Company G moved from Madison Barracks to Fort Ontario on 15 May. Company H moved from Madison Barracks to Fort Porter, New York, also on 15 May. Company M was transferred to Fort McPherson, Georgia on 16 May. On 18 June Company E left Madison Barracks and went to Plattsburg Barracks. Just as the companies were beginning to get settled into their new stations, the Regiment received orders on 7 July to move to San Francisco in preparation to deployment to China for action in the Boxer Rebellion.

The next installment will cover the Regiment's participation in the Boxer Rebellion.

### NOMINATION OF CANDIDATES FOR ELECTION

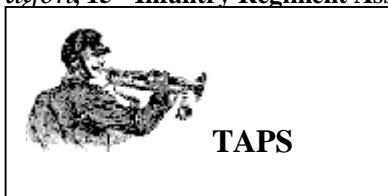

**Financial Report**

The income column is pretty well self-explanatory. We have several members delinquent in 2001 dues. Letters have been sent to those delinquent. Hopefully they will respond with favorable results.

The Expense Column: I wish to remind all members again, the expenditures by the officers are for daily Assn. business. No expenditures are for lodging, food, travel or salaries. Mainly it is for postage, printing, copies, phone calls and office supplies. As you can see printing and mailing the Association newsletter, The Dragon four times a year is the Assn. biggest expense.

The Association assisted in the expenses, in co-sponsoring a buffet and icebreaker at the Rendezvous in April. At the Third Infantry Division reunion in San Francisco, we had some expenses at the hotel for the podium, microphone and bar setup. The Assn. also picked up the cost of the regimental banquet meals for the 7-member honor guard, NCO and soldier of the year from Ft. Benning.

The life membership in the Vanguard account has grown from \$5500 in March, 22,1999 to \$7,106.65 as of December 31,2000, on an increase of \$1,606.65 in the last two years. Twenty-five percent of life membership income per year is transferred to the fund. Raffle income is a major source of funds, to help bring the life membership account closer to being actuarially sound. Funds were also transferred from the checking to the Vanguard account for a better interest rate. With continued support of the raffle, we can maintain our dues structure at \$10 year.

This will be my last report as treasurer of the Association. At my request, I have asked to be replaced because of health reasons. I will continue to help the Assn. as assistant treasurer, chairman of the raffle mailing and public affairs person. It has been a labor of love and a pleasure to work with all the officers and trustees of the Assn.

The HHC/3-15 IN (M) 'Headhunters' are currently deployed for Operation Joint Forge as peacekeepers in Bosnia-Herzegovina. The Company deployed nearly 250 soldiers in September 2000 for a six-month rotation to the region. Headquarters and Headquarters Company deployed the bulk of the company from Fort Stewart, Georgia to include the Mortar Plt, Scout Plt, Support Plt, Medical Plt, Maintenance Sect, Communications Sect, HQ Plt, and the Battalion Staff. Upon arrival in the Balkans, the Mortar Plt occupied Hill Top 722. The Mortar men are located just outside the small town of Srebrenik, that was built around a 12th century Turkish castle. There they secure a vital communications node for the 3rd Infantry Division and conduct daily patrols to project an American presence in their area of operations.

The men of the 'Can Do' Regiment are in good spirits. They have delivered school supplies and gifts to children at some of the local elementary schools. In a country where the evidence of a recent war still scars every building, the soldiers of the China Regiment are making a difference in the daily lives of thousands. Many of these same men just recently returned from Kuwait where they patrolled and trained a few kilometers from the Iraqi border. Now they are able to see the faces of those they are helping throughout the Bosnian countryside.
